Admissions Policy

The purpose of this program is to further develop skills that can help support people's health at all levels by acquiring the ability to develop nursing science in a practical and creative manner. This program further aims to advance a deeper understanding for the dignity of life and human existence by utilizing advanced practical abilities to respond to changes in the health, medical, and welfare environments, in addition to education and research capabilities in the field of nursing.

Desired student profile:

- 1) A well-rounded character with academic ability, and a clear desire to study or research at a graduate school level.
- 2) Active in the clinical or educational fields of health, medical care, and welfare with the ambition to improve as a nursing professional.
- 3) A strong interest in nursing science or nursing practice and an eagerness to engage in academic activities after entering the school.
- 4) A willingness to contribute to society as a skilled nursing practitioner, nursing educator, or nursing researcher.

Curriculum Policy

For those entering the Master's Program, a **Special Research Course (SRC)**, a **Global Nursing Course (GNC)**, and a **Certified Nurse Specialist Course (CNSC)** * have been established to further develop nursing practitioners, educators, and researchers. The SRC curriculum is designed to explore the theory of nursing science and enhance the research ability necessary to build on this theory, while the GNC curriculum provides the research capabilities needed to contribute to global health challenges. The CNSC curriculum is designed to examine advanced practical and research abilities in the field of practice.

The results of the students' research and study are evaluated comprehensively based on criteria specified in advance. The outcomes of these evaluations will be used to facilitate improvements in our approach to education.

- 1) General Subjects
The SRC, the GNC, and the CNSC general education courses are offered to students to acquire a wide range of knowledge that will serve as the foundation for research methods, ethics, and learning.
- 2) Specialized Subjects
Specialized subjects are provided to students to obtain the ability to perform, either locally or internationally, in the roles of advanced nursing practitioners, educators, and researchers in their respected fields.
- 3) Practice and Research Guidance
For those enrolling in the SRC or GNC, the main focus will be on specialized research, while those entering the CNSC, issue-based research will be conducted. Practice guidance is provided to identify specific issues, where students will acquire advanced specialized research methods, and be required to prepare a master's thesis to develop the ability to logically summarize academic results.

* Certified Nurse Specialist Course (CNSC) is currently unavailable for Global Nursing Course students.

Diploma Policy

A Master's in Nursing degree will be granted to those who have been enrolled in the standard 2-year term of study, earned the credits required for completion, obtained the qualifications and abilities stated below, and passed the review and final examination of their master's thesis or thesis research project.

- 1) The ability to engage in specialized research in the nursing field with high ethical standards.
- 2) The ability to systematize the extensive knowledge necessary to demonstrate a high level of expertise and practice a high quality of nursing care.
- 3) The ability to contribute globally to society through advanced nursing practice, research, and educational activities.

3 Application Eligibility

Those who are eligible to apply for the 2025 Master's Program must be one of the following and meet one of the criteria (1) through (9) below.

- Those who are recommended by the Japan International Cooperation Agency (JICA).
- Those who are enrolled in or working at a university with which Juntendo University has an academic exchange agreement (MOU, Memorandum of Understanding), as well as graduates and alumni of such universities.

(Please refer to the website of the Graduate School of Health Care and Nursing for a list of the universities with which Juntendo University has academic exchange agreements)

- (1) Applicants who have graduated from a course in nursing or health science at a university in Japan or are expected to graduate by the time of admission.
- (2) Applicants who have been granted a bachelor's degree (in nursing or health science) by the National Institution for Academic Degrees and Quality Enhancement of Higher Education pursuant to the provisions of Article 104, Clause 7 of the School Education Act, or applicants who are expected to be granted a bachelor's degree (in nursing or health science) by the institution by the time of admission.
- (3) A person who has completed or is expected to complete 16 years of schooling (with the last course taken being either nursing or health science) in a foreign country by the time of admission.
*1 Applicants must confirm they meet the preliminary confirmation of eligibility.
- (4) Applicants who have completed or are expected to complete 16 years of schooling (with the last course taken being either nursing or health science) by a distance learning course administered by a school outside of Japan, while living in Japan by the time of admission.
- (5) Applicants who have graduated from an educational institution (restricted to graduates of nursing or health care science) in Japan that is recognized by a country outside of Japan as corresponding to the university curriculum in that country's educational system (restricted to curriculum whose graduates are considered to have completed 16 years of school education in that country), and which has been approved by the Ministry of Education, Culture, Sports, Science and Technology (Locations in Japan of a Foreign University designated by the Minister of Education, Culture, Sports, Science and Technology), or applicants who are expected to have completed such a course by the time of admission.
- (6) Applicants who have obtained a degree equivalent to a bachelor's degree (in nursing or health care science) by graduating from an academic program at least 3 years in length ^{a)} at a school or university outside of Japan, ^{b)} or applicants that are expected to have obtained such a degree by the time of admission.

*1 Applicants must confirm they meet the preliminary confirmation of eligibility.

- a) Applicants who have graduated from a distance learning course administered by a school outside of Japan while living in Japan or from an international school in Japan, whose

curriculum corresponds to a country outside of Japan and has been approved as per the previous item (Locations in Japan of a Foreign University designated by the Minister of Education, Culture, Sports, Science and Technology) are also qualified to apply.

- b) Applicants must have graduated from an institution certified by a government or accreditation institution outside of Japan that reviews academic and research activities, or that has been approved by the Minister of Education, Culture, Sports, Science and Technology.
- (7) Applicants who have completed, or are expected to complete by the time of admission, a specialized course of study at an advanced vocational school (limited to those satisfying the requirement that the term of study is four years or more and other standards specified by the Minister of Education, Culture, Sports, Science and Technology) designated separately by the Minister of Education, Culture, Sports, Science and Technology (List of Training Institutes Designated by the Minister of Education, Culture, Sports, Science and Technology) on or after the day designated by the Minister of Education, Culture, Sports, Science and Technology.
- (8) Applicants who have completed a course in nursing science or a course in health care science at a former education school, etc. (1953 Ministry of Education Notification No. 5, Nos. 1 to 4, 1955 Ministry of Education Notification No. 39, No. 1).
 - *1 Applicants must confirm they meet the preliminary confirmation of eligibility.
- (9) Applicants who are recognized by this graduate school through individual screening of eligibility for admission as having scholastic ability equivalent to or higher than that of university graduates and who will be 22 years of age by the time of admission (applicants who do not fall under (1) to (8) above but hold a license for either Public Health Nurse, Midwife, or Nurse, and has professional experience of engaging in work that requires such licenses for 3 years or more at the time of application [selection of working adults], etc.).

12 Notes

- (1) After the application has been received, the entrance examination fee will not be refunded under any circumstances.
- (2) Applicants who are expected to graduate but fail to do so, their admission will be revoked even if they have been accepted.

Security Export Control (for non-Japanese examinees)

In accordance with the Foreign Exchange and Foreign Trade Act, which seeks to protect both national and international peace and security, Juntendo University has established the Juntendo University Security Export Control Regulations to preserve academic and research activities. International students accepted into the graduate school program should consult with their supervising professor about their research prior to submitting the application since there are cases where students may need to modify their application due to their research proposal. International students accepted into the graduate school program must sign a pledge indicating they will comply with the Foreign Exchange and Foreign Trade Act at the time of their enrollment.

13 Degree Conferred

Persons who have acquired the designated credits from the Graduate School of Health Care and Nursing (Master's Program) at Juntendo University Graduate School, and who have passed the review of their thesis and the final examination will be awarded the Master's in Nursing degree.

15 Completion Requirements

The requirements for completion at the Graduate School of Health Care and Nursing (Master's Program) are as follows: a student enrolled in the course for at least 2 years; acquired a total of at least 30 credits consisting of at least 8 credits from the general subjects, including 4 credits from compulsory subjects; at least 10 credits from specialized subjects; and at least 8 credits from practice and research guidance, including 4 credits from general subjects; and submitting a master's thesis or research thesis upon having received the required research supervision, and pass the review and final examination.

Please receive guidance from your academic advisor in advance when choosing subjects. The enrollment period may be shortened for those who have achieved excellent research results and have been enrolled for at least one year.

Doctoral Program

Admissions Policy

The purpose of this program is to further develop skills that support people's health at all levels by acquiring the ability to develop nursing science in a practical and creative manner. Furthermore, this program aims to develop talent who can play an active role internationally by applying rich academic knowledge and can independently advance research in the field of nursing, further contributing to improvements in health and novel developments in the medical environment.

Desired student profile:

- 1) A well-rounded personality who is inquisitive and willing to pursue research independently from the perspective of nursing science.
- 2) A strong intellectual interest in the field of nursing with the aim of achieving world-class research.
- 3) A desire to contribute to the development of nursing science and the improvement in the quality of nursing care as an advanced nursing practitioner, science educator, or science researcher by utilizing the higher education and research abilities acquired.

Curriculum Policy

The Doctoral Course consists of general subjects, specialized subjects, and practice and research guidance with the aim of cultivating research abilities to pioneer new fields, such as nursing support for individuals, their families supporting them, and people living in the community. The aims of the **Nursing Research and Development Course** curriculum are the development of educational support for nurses and the establishment of nursing provisional systems. For the **Global Nursing Leadership Course** curriculum, the objectives are to develop talent who can take a leadership role in developing high quality nursing systems and management for countries, regions, and diverse cultures worldwide.

The results of the students' research and study are evaluated comprehensively based on criteria specified in advance. The outcomes of these evaluations will be used to facilitate improvements in our approach to education.

- 1) General Subjects
The purpose of these general education subjects is to link high quality research results based on the ability to explore the essence of nursing science with high ethical standards and a sense of responsibility.
- 2) Specialized Subjects
The purpose of these specialized courses is to enable students to conduct practical research on a wide range of health and nursing issues. Students acquire more advanced research skills, such as verifying knowledge and technologies in nursing science and establishing new theories and methodologies. They learn about nursing issues and research approaches related to their own research themes from a multidisciplinary perspective and cultivate an academic foundation. Based on the fields of the master's program (MS), 13 subjects will be established with the aim of instilling advanced specialized knowledge and academic perspectives on nursing support development, management systems, and educational support for individuals, the families who support them, and people living in the community.
- 3) Practice and Research Guidance
Nursing Practice and Nursing Special Research have been established with the aim of acquiring research abilities that will sharpen and deepen the research necessary for instructors, researchers, and managers who are capable of conducting educational and research activities at nursing universities and health organizations in Japan and overseas. Furthermore, to nurture highly specialized professionals with scientific perspectives in health, medical, and welfare fields to exercise their educational and research abilities.

Diploma Policy

The degree of Ph.D. (Nursing) will be granted to those who have been enrolled in the standard 3-year term of study, earned the credits required for completion, obtained the following qualifications and abilities stated below, and have passed the review and final examination of their doctoral dissertation.

- 1) The ability to research and develop new theories and nursing care based on high-level academic knowledge, advanced specialized knowledge, and practical ability.
- 2) The ability to contribute to academic exchanges and health care activities on an interdisciplinary and international basis as a leader, manager, educator, or researcher with outstanding expertise, ethics, and a heightened sense of responsibility.

3 Application Eligibility

Those who are eligible to apply for the 2025 Doctoral Program must be one of the following and meet one of the criteria (1) through (7) below.

- Those who are recommended by the Japan International Cooperation Agency (JICA).
- Those who are enrolled in or working at a university with which Juntendo University has an academic exchange agreement (MOU, Memorandum of Understanding), as well as graduates and alumni of such universities.

(Please refer to the website of the Graduate School of Health Care and Nursing for a list of the universities with which Juntendo University has academic exchange agreements)

- Those who plan to apply to the CSC (China Scholarship Council) - JUNTENDO Scholarship Program

(Please refer to the Juntendo University website for details on eligibility requirements)

However, for those who plan to apply for the CSC (China Scholarship Council) - JUNTENDO Scholarship Program, those who have passed the entrance examination stipulated by the Graduate School and have been selected by the China Scholarship Council will be accepted for admission and will be exempted from the entrance examination fee, entrance fee, and tuition fee.

- (1) Applicants who have been awarded or are expected to be awarded by the time of enrollment, a master's degree or professional degree.
- (2) Applicants who have been awarded or are expected to be awarded by the time of enrollment, a master's degree or a degree equivalent to a professional degree from a foreign country.
*1 Applicants must confirm they meet the preliminary confirmation of eligibility.
- (3) Applicants who have been awarded or are expected to be awarded by the time of enrollment, a master's degree or a degree equivalent to a professional degree via distance learning course administered by a school outside of Japan, while living in Japan.
- (4) A person who has completed a course of study at a non-Japanese school designated in Japan as equivalent to a non-Japanese graduate school (Locations in Japan of a Foreign University [graduate school equivalent] designated by the Minister of Education, Culture, Sports, Science and Technology) and has been awarded, or is expected to be awarded by the time of enrollment, a degree equivalent to a master's degree or a professional degree.
- (5) Applicants who have attended United Nations University and have been awarded or are expected to be awarded by the time of enrollment, a degree equivalent to a master's degree.
- (6) Applicants who have been approved by the Minister of Education, Culture, Sports, Science and Technology (Ministry of Education Notification No. 118 of September 1, 1989).

*2 Preliminary eligibility review required.

- ① Applicants who have graduated from a university and has engaged in research at a university, research institute, etc. for two years or longer, and who is recognized by the Graduate School as having the academic ability equivalent to or higher than that of a person who holds a master's degree based on the results of said research.
 - ② Applicants who have been engaged in research at a university, a health organization, or equivalent, for 2 years or more after completing 16 years of school education in a foreign country or after completing 16 years of school education in a foreign country via distance learning course taken while living in Japan, and who are recognized by the Graduate School to have the scholastic ability equivalent to or higher than that of a person who holds a master's degree based on the outcome of said research.
- (7) Applicants whom the Graduate School has recognized through separate preliminary eligibility review as possessing the equivalent or greater academic ability than a person with a master's degree or professional degree and who are 24 years of age or above by the time of enrollment.
